The half board price is **27 euros** a day, including:

→ Accommodation in single room

→ Breakfast and dinners (Saturday and Sunday included)

Add to the booking an amount of **50 euros** for administrative fees.

GENERAL CONDITIONS:

Article 1 : Descriptive.

The student has a single room (bed, closet and desk).

Article 2 : Services.

The host family provides the following services for free:

→ Reception of the student at the railway station or the airport ;

→ House key ;

→ Bed sheets and bath towels ;

→ Support of AFAR 17 for the administrative files ;

→ Possibility to have the Wi-Fi family connection.

Article 3: Price of the stay.

The price of the stay is 27 euros per day corresponding to the daily room fee, rental cost included (heating, water, electricity).

Article 4: Payment of the stay.

1. To validate your inscription, make sure to return at short notice:

a. The contract completed and signed.

b. The student charter signed.

c. The payment of **50 euros** for the administrative fees + **the payment of the first month of stay**. Payments must be submitted to AFAR 17, by check,

For payments in USD you should settle your bills by semester in order to limit bank charges.
